

GUIDELINE FOR MEMBERSHIP OF ILTA

Eligibility for Life / Ordinary Membership (Min. any one of the Following)	Eligibility for Honorary Membership	Eligibility for Associate Membership (Min. any one of the Following)
1. A person having Degree in Leather Technology / Footwear from any recognized University of India or Abroad.	A person having outstanding activities, status, performance and research – either in national or international scenario in the field of Leather and Allied Industries, may be awarded with Honorary Membership. The proposal should come through a Sub-committee appointed by the Executive Committee of ILTA and subsequent approval of the said Executive Committee	1. A person having completed at least 1 year course in Leather / Footwear / Leather Goods / Garments / Designing from any recognized Institution, will be eligible for Associate Membership after 5 years – subject to approval of Executive Committee.
2. A person having minimum 2 years Diploma course in Leather Technology from any recognized University of India or Abroad.		2. A person holding Degree in any Engineering or Technology stream with 2 years experience in Leather Industry.
3. A person having minimum 2 years Certificate Course in Leather / Leather Goods / Garments / Footwear from a recognized University / Institution.		3. A person holding Diploma in any Engineering or Technology stream with 5 years experience in Leather Industry.
4. Any Industrialist having outstanding status, performance and contribution in the field of Leather / Allied Industries, either in national or international scenario.		4. Any Degree Holder in any stream who has at least 10 years experience in Leather Industry.

Note :- The Associate Members under category no (2), (3) & (4) will be considered by Executive Committee for Ordinary / Life membership after 5 years of continuous Associate Membership through evaluation of their activities and contribution for the Association and the Leather Fraternity as a whole.
Candidates failing to meet the required norms in one attempt can apply for re-evaluation only after 2 years.
